Drivers for change


2018 research into how New Zealand is providing for walking, with particular focus on existing guidance and policy

- It involved:
 - an industry survey to determine current use and gaps
 - a review of all relevant guidance



Drivers for change (cont.)

- It recommended to:
 - combine Pedestrian Planning and Design Guide (PPDG) and Road and Traffic Standards (RTS) 14 into one guidance
 - create an on-line guidance
 - better reflect:
 - inclusive access
 - safe system
 - One Network Framework



Drivers for change (cont.)

On-line guidance

- Easily reachable by a wider audience
- Easier to read and more images
- Meets the Government Accessibility Standards
- Easier to update
- Aligns with and interacts with other Waka Kotahi guidance



Key changes

- New topics
 - Walking in NZ
 - Implementation (inc. monitoring)
 - Reviews and audits

- Updated design topics
 - Paths
 - Midblock crossings
 - Intersections


