Entry requirements and rules

Prizes

Each award category winner will receive a framed certificate and stylish award.

The Golden Foot Awards

The awards are organised and run by Living Streets Aotearoa and developed with the assistance of the NZTA. The judging panel is appointed by Living Streets Aotearoa.

Living Streets Aotearoa is New Zealand's national walking and pedestrian organisation, providing a positive voice for people on foot and working to promoting walking friendly planning and development, and working towards 'more people walking more often'.

The awards are designed to recognise walking friendly innovations that have improved standards and gone beyond statutory requirements or 'everyday business' of organisations.

Rules of entry

Nominations are welcome from individuals, public bodies, not-for-profit organisations or private businesses

The project must be new and in New Zealand. Ideas and inspiration from overseas are welcome, but entrants must show how it is relevant, innovative and making a difference within New Zealand.

All projects must have been completed between 1st July 2009 and 30st June 2010.

Each project can be entered for one category only. Please choose the most suitable category. If the organising committee consider that a different category is more appropriate, entrants will be contacted for their agreement.

The deadline for entries is 5pm on 30th June 2010. Entries must be received before the deadline. Late submissions will not be considered.

All entries must be emailed, however additional material can be sent by post, Entries will not be returned.

The judges may call upon technical experts if required to assess the quality of any project.

Finalists will be notified by email prior to the ceremony. All are welcome at the ceremony but there is no funding for travel or accommodation.

The judges' decision is final.

Details from the nominations may be used in promotional material for the ceremony and in following years. Entrants agree to material being used for reasonable promotional material.

Judging criteria

For all categories, the judges will be looking for:

- originality or innovation
- recorded and significant positive results for walkers
- projects that meet a clear need or solve a specific problem
- demonstrated best practice for walkers, that can be replicated in other schemes
- engagement with key stakeholders.
- A project that will continue to demonstrate success or leaves a legacy beyond the life of the project

Entry format

All entries must complete the nomination form on our website, www.livingstreets.org.nz/walking-awards2010-entry-form and email further details of the project including.:

Project summary (up to 300 words)

Project statement (up to 2000 words)

- Background
- Need for the project
- Aims of the project
- Project description including budget and funding sources
- Results of the action taken
- Evaluation and possible improvements
- Agencies / people involved
