Thank you for the opportunity to comment on these traffic resolutions.

TR 12-23 EV charger parking Ngaio Townhall Library car park  
Living Streets Aotearoa support the location of these EV chargers in a dedicated vehicle parking area away from the footpath.

TR 04-23 No stopping lines by bus stop on Wallace Street  
Living Streets Aotearoa support this traffic resolution that will allow an increase to the narrow footpath beside this busy bus stop. This will improve the experience of about 9,000 people's daily trips.

TR 05-23 No stopping around bus stop Newlands  
Living Streets Aotearoa supports this traffic resolution that will improve bus journey for at least the 350 people using this stop daily.

TR 07-23 Motorcycle parking  
Living Streets Aotearoa supports this parking as we are aware there is an issue with motorbikes parked on the Wigan Street footpath currently. Opportunities to park motorbikes legally is needed in many places around Wellington.

TR 09-23 Grasslees reserve mobility parking  
Living Streets Aotearoa supports these parks. Appropriate access to greenspace is essential for all people.

TR 11-23 EV charger parking Mervyn Kemp library Tawa  
Living Streets Aotearoa support the location of these EV chargers in a dedicated vehicle parking area away from the footpath.

TR 14-23 Tawa Street, Tawa - P120 Time Limited Parking; Install Bus Stops  
Living Streets Aotearoa support the installation of the new bus stops. We note the bus shelter is 1.2m wide and would like to ensure that 1.8m clear footpath remains around this infrequently used shelter.

TR 17-23 Doctor Taylor Terrace, Johnsonville – Mobility Parking relocation; Raised pedestrian crossing  
Living Streets Aotearoa support the installation of the raised pedestrian crossing to make travel safer for nearby schools and residents.
